## ROSA MYSTICA

**H**aving acknowledged that the places and structures in our Diocese of Brescia in the *Fontanelle* area, in the territory of the parish of Santa Maria Immacolata in Borgosotto di Montichiari (BS), have become in recent decades an important spiritual reference point and a place of pilgrimage for thousands of faithful from Italy and abroad;

Considering that the historical origin of this imposing phenomenon of prayer and veneration towards the holy Mother of the Lord – invoked here as “*Rosa Mystica - Mother of the Church*” – is linked in a way

that is not secondary to the spiritual experience of Pierina Gilli (1911-1991);

Noting that the historical origin of this phenomenon and its subsequent developments are currently the subject of a renewed phase of study and discernment on the part of the ecclesiastical authority, also in order to better understand if and how, in the present, it may favor and increase the Christian life of pilgrims, and considering its convinced affinity to the Church and the sharing of its evangelizing mission under the protection and inspiration of the One who has always been exalted for Her immaculate holiness, Her closeness to God and to men, and Her maternal mediation;

Considering that since 2001 my esteemed Predecessors, in strict agreement with the indications of the competent organs of the Apostolic See, constantly reaffirmed the importance of welcoming and recognizing the exercise of public worship in the aforementioned places, moderating it through the promulgation of special diocesan directories;

Considering the importance of recognizing also on the canonical level the missionary potential of these sacred places, in order to consolidate, strengthen and increase the numerous spiritual fruits germinated here over time, as well as to offer the dutiful and ecclesial pastoral care of the pilgrims, especially




The approval of a new Statute of the new Sanctuary and the appointment of the Rector will be provided as soon as possible.

# HOMILY OF THE BISHOP DURING THE MASS OF THE CONSTITUTION OF THE SANCTUARY

**O**n this eve of the Solemnity of the Immaculate Conception, in the radiant light of her mystery of grace and glory, profoundly grateful to God, we have the joy of starting here in this place, a new phase of the journey. With this celebration, and with the decree that has been proclaimed, today we constitute here, in Fontanelle, the diocesan shrine of Maria Rosa Mystica and Mother of the Church.

In fulfilling this solemn act, we actually insert ourselves in a furrow opened by those who preceded us, by the great crowd who up to now have prayed in this place with faith and opened their hearts to the action of the Holy Spirit, capable of converting and regenerating to the life of faith. And we also feel in communion with the thousands of people in the world who turn to the Blessed Virgin Mary, invoking her as Rosa Mystica and Mother of the Church, drawing inspiration from this place and from the events related with it.

Encouraged by the support of the Holy See and in full communion with the Supreme Pontiff Francis, we have the joy of dedicating this sanctuary to the Mother of the Lord, recognizing in her the full truth that these two suggestive qualifications express.

Rosa Mystica, flower of grace in which the beauty of redemption finds a privileged and singular manifestation; flower of tenderness, in which the petals form an embrace that tightens around a secret nucleus, guarded in

its precious beauty; a flower, symbol of the Church itself, a communion of saints that flows as from a source from the side of Christ crucified, in the power of the Holy Spirit.

And how can we not think of the perspective in the admirable vision in the final song of the Paradise of Divine Comedy? Saint Bernard, the mystic accompanying Dante in the last part of his journey, standing still before the Virgin in all her dazzling beauty and reflecting on the mystery of the incarnation who saw her as the protagonist, says of her: "Within thy womb rekindled was the Love, through whose warm influence in the eternal Peace this Flower hath blossomed thus". The flower germinated by the warmth of Christ's love in the work of redemption is the rose of the blessed, that is, the entire Church in the splendour of its holiness.

Thus, the qualification of the Virgin as "Rosa Mystica" is well united with that

of "Mother of the Church". Together with her, the flower of Grace, also the disciples of the Lord, his brothers in the faith, form the holy people of God; they become witnesses of the Gospel, announcing the beauty of the Kingdom of God, spreading in the world the fine perfume of Christ. And the Mother of Jesus, the God with us, also becomes the Mother of the Church: she involves the Church in Her generating power, defends her from evil, supports her on the path of conversion, consoles her in trials, sanctifies her in the truth and inspires her to carry out her missions.

I wish that in this light, each of us contemplates this sanctuary that we have constituted today. That in the wake of what has been lived until now, it may become more and more a place to feel the power of grace that is born of faith in Jesus Christ and of devotion to his holy Mother.

Let it be a place in which to grow as a church and in which to pray for the Church. The water of this source





reminds us of the Baptism that every Christian has received; it reminds us of the fact that today the Church needs to return to the essence of her reality, her holiness, the experience of grace in the power of the Holy Spirit.

May this sanctuary be a place to live ever more intensely the beauty of belonging to the Church of the Lord, as a people redeemed by His blood, with a royal priesthood and as a holy nation.

May it be the place in which we can experience the divine power of conversion, of rebirth, of salvation, but also of consolation and hope in constant prayers and celebrations of the Sacraments.

May here, along with prayer, also the awareness of the value of penance and sacrifice be cultivated: of the loving daily offering of our proper life in communion with Christ the Redeemer and of penance as a lifestyle, capable of counteracting a worldliness that extinguishes the joy of the heart.

May it also be a place in which to raise intercessory prayer, in communion with the holy Mother of God, Rosa Mystica and Mother of the Church. Let us pray in this sanctuary for the holiness of the whole Church, and in particular for its ministers, for those whom the Lord has called to a life of consecration.

Let us ask for them the grace of holiness, a clear and joyful witness, asking forgiveness for all their guilt and for the evil caused by them to the mystical body of the Church. Let us ask the Blessed Virgin Mary to preserve, accompany and support all consecrated men and women in their noble mission of promulgating the Gospel.

And while we say all this, we cannot but think of the testimony of Pierina Gilli. This place is linked to her and draws

her spirituality from her unique experience. The Church is in her maternal solicitude, called to listen to the signs of the Spirit.

The times and the ways of spiritual discernment are part of a providential design, whose contours often escape our clear vision. So let us keep ourselves open to the will of the Lord and continue this discernment about the events that happened in this place. We are encouraged by the full communion between our Diocese and the Holy See, in the common desire to truthfully inter-

pret the extraordinary experience lived by Pierina Gilli in great humility and with sincere faith. The Blessed Virgin Mary will also watch over this path that continues.

We entrust this sanctuary to the holy Mother of the Lord, Rosa Mystica and Mother of the Church. We ask her to make it more and more a place of grace. From Her we hope every good for our diocesan Church and for the whole Church.

May the Immaculate Virgin help us all to understand how to offer our lives in an ever more and better way, to announce the beauty of the Gospel. To all a sincere wish for a Holy Christmas and a New Year of Grace in the Lord Jesus!

## Open letter to the Diocese

Brescia, November 21, 2019

Dear All,

The places and structures in our Diocese in the Fontanelle area, in the territory of the parish of Santa Maria Immacolata in Borgosotto di Montichiari (BS), have for many years become an important spiritual reference point and a place of pilgrimage for thousands of faithful from Italy and from abroad.

This impressive phenomenon of prayer and veneration towards the holy Mother of the Lord – here invoked as Rosa Mystica and Mother of the Church – is linked in a way that is not secondary to the spiritual experience of Pierina Gilli (1911-1991), an experience that is the subject of a renewed phase of study and discernment by the ecclesiastical authority, both at the diocesan level and in the Congregation for the Doctrine of the Faith.

The purpose of this in-depth investigation is to better understand whether and how this kind of spiritual experience can promote and increase the current Christian life, the sense of belonging to the Church and the participation in their mission of evangelization, under the protection and inspiration of the Holy Mother of the Lord.

Since 2001, my esteemed predecessors, in strict agreement with the indications of the competent organs of the Apostolic See, constantly reaffirmed the importance of welcoming and recognizing the exercise of public worship in the Fontanelle area, moderating it through the promulgation of special diocesan directives.

It is a joy for me to inform you that at my explicit request, the Apostolic See itself, through the Congregation for Worship, has allowed the Diocesan Shrine Rosa Mystica - Mother of the Church to be instituted at this location and I willingly intend to establish it with a special decree, starting from 7 December 2019. On that occasion – the eve of the Solemnity of the Immaculate Conception – I will personally visit these places to solemnly celebrate the Eucharist, thus inaugurating the spiritual path of the diocesan sanctuary.

### PLENARY INDULGENCE BY THE CHURCH

*List of liturgical days in which the Plenary Indulgence is granted in ordinary form, under the usual conditions, at the Diocesan Shrine Rosa Mystica Mother of the Church*

- January 1: Solemnity of the Mother of God
- March 25: Solemnity of the Annunciation of Mary
- Every Friday of Lent
- Sunday Solemnity of the Divine Mercy (2nd Easter day)
- Sunday of Pentecost
- Sunday of the Solemnity of Corpus Christi
- Solemnity of the Sacred Heart of Jesus (Friday after Corpus Domini)
- August 15: Solemnity of the Assumption of Mary
- November 2: Commemoration of the Faithful Dead
- Sunday of the Solemnity of Christ the King of the Universe
- December 8: Solemnity of the Immaculate Conception
- December 31: Memory of St. Silvester
- Once a year, on a day chosen by the faithful (eg: birthday, anniversary of baptism, marriage, sacred ordination, of religious vows etc.)
- On the occasion of a collective pilgrimage to the Sanctuary

With such a solemn proclamation, the missionary potential of these sacred places is, in fact, also recognized on the canonical level, in order to consolidate, strengthen and increase the numerous spiritual fruits germinated here over time. To this end, I would like the pastoral care of pilgrims to be intensified and to be well understood, to remain constant and that the celebrations of the Sacraments of Confession and the Eucharist will be even more active and fruitful. I also intend to provide soon for the appointment of the Rector of the Sanctuary and for the definition of the statutes concerning the life and activity of the sanctuary itself.

Grateful to the Lord for this gift that enriches our diocesan church, we entrust our journey to the Holy Mother of God and invoke from her the grace of an ever more intensely faith, lively hope and an active charity.

I affectionately invoke the Lord's blessing upon all.
